TERMS AND CONDITIONS OF CREDIT SALES

- 1. Our terms are net 10th of the month unless otherwise specified.
2. Interest of 1-1/2% per month, which is an annual percentage rate of 18%, is charged on all past due balances.
3. A fee of \$20.00 will be charged for any and all returned checks.
4. The federal Equal Credit Opportunity Act prohibits creditors from discriminating against the Applicants on the basis of race, color, religion, national origin, sex, marital status, age (provided the Applicant has the capacity to enter into a binding contract), because all or part of the Applicant's income is derived from any public assistance program, or because the Applicant has in good faith exercised any right under the Consumer Credit Protection Act.
5. Mascott Equipment Company reserves the right to discontinue sales on credit at any time and for any lawful reason.
6. All shipments will be FOB shipping point.
7. Applicants hereby grants Mascott Equipment Company a security interest in all equipment purchased by Applicant from Mascott Equipment Company and all profits and proceeds thereof.
8. In the event of nonpayment of any invoice, Applicant shall reimburse Mascott Equipment Company for all costs and expenses reasonably incurred by Mascott Equipment Company in connection with the default, including without limitation, attorney fees.
9. The manufacturer's specifications for product(s) sold meet safety code requirements of the state of use.
10. Applicant agrees that invoices and monthly statements are conclusive and accurate in all respects unless Applicant notifies Mascott Equipment Company in writing within ten (10) days of receipt of the invoices or statements.

The undersigned Applicant represents that all information on this Application is true and correct and agrees to comply with all terms and conditions stated in the "Terms and Conditions of Credit Sales." The Applicant and the guarantor authorize Mascott Equipment Company to obtain credit reports as to Applicant, the owners of Applicant and guarantor, and to otherwise verify financial information. This Application is to obtain commercial credit to be used for business purposes and not primarily for personal, family or household purposes.
